TEST 1

PLANT TESTING

Each cultivar must meet New York state's Department of Agriculture compliance requirements of 0.3% THC (or less) before harvest begins.

TEST 2

EXTRACTION TESTING

Once all the crops are stripped and stored in a climate controlled facility, the hemp is sent to our extraction partner, who processes the biomass into CBD and CBG Isolate. After extraction, the isolate is again tested to meet High Fall's internal requirement to ensure that the isolate is free of heavy metals, pesticide residual solvents and biological contaminants.

TEST 3

PRODUCT TESTING

After all the hard work of cultivating and extracting, our lotions are then formulated at our FDA registered lab. To assure you are receiving the purest CBD products, our finished goods are again sent out to an independent lab to ensure they meet the potency and safety panels, and other requirements of all state and Federal agencies, consistent with what is on the label. The lab report being shown here is that of the finished products made by High Falls Hemp NY.

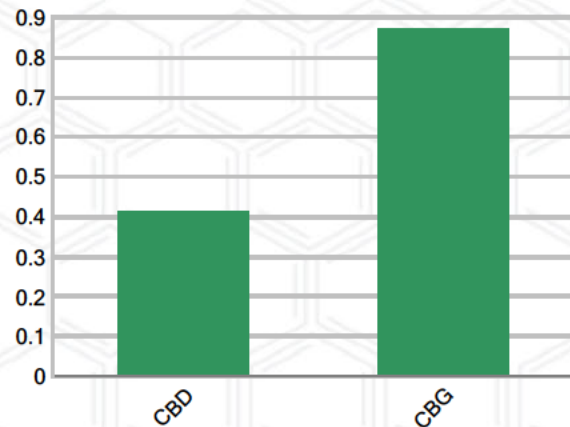
